Jennifer Langston has been in recovery from opioid use disorder for over 10 years. She serves as Executive Director of Reboot Jackson, a recovery community organization based in Jefferson, Georgia. She received her CPS-AD in 2018 and subsequently has earned a MATS certification as well as an FPM certification. She holds a BS in Psychology from Brenau University.

Over the past 5 years as Executive Director of Reboot Jackson, she has developed strong collaborative relationships within her county, region, and across the state. She has served as board chair for the Jackson County Family Connection since 2022. She also has served as a board member for Jackson County DFCS since 2022. Service to these boards, as well as her community, has taught her the ability to objectively collaborate while looking out for the best interests of the community as a whole.

She was named the Jackson County Citizen of the Year in 2021 and Jackson County Woman of the Year in 2023. She also serves on the Community Impact Committee for the Georgia Recovers Campaign, a position which allows her to effectively combat the stigma which surrounds substance use disorder while providing hope for people who may be seeking recovery. She assists other recovery community organizations in strategic planning and resource development and understands the gravity and complexity of making regional decisions that will impact the services offered to Georgians who are in need of prevention, treatment, recovery, and harm-reduction services. The most important people to Langston are the ones who are directly impacted by the opioid crisis and their families, and her goal is to ensure that they are given the most equitable opportunities to recover.

Judge Brenda Holbert Trammell grew up in Morgan County, Georgia, attending Morgan County High School. After graduating from Tift College in Forsyth, Georgia, she attended the University of Georgia Law School, graduating in December 1977. After graduation, she began her law career as a sole practitioner in the Atlanta area, where she remained until returning to Madison in 1993. Prior to her appointment to the bench, Judge Trammell had a successful solo practice in Madison, Georgia, litigating in all of the eight counties in the Ocmulgee Judicial Circuit - both civil and criminal. She also had a busy appellate practice.

Governor Nathan Deal initially appointed Judge Trammell to the Superior Court bench on January 14, 2015, and she is presently serving as the Chief Judge of the Ocmulgee Circuit. Her office is located in Eatonton, Georgia.

Judge Trammell has been involved in accountability courts since her appointment to the bench, and presides over the Ocmulgee Circuit Adult Treatment Court, Mental Health Division. She has served on both the Certification Committee for CACJ, and for several years, and currently, serves on the Funding Committee. Judge Trammell also serves as the Chair of the Georgia Board of Court Reporting.
